

## **APRICITY SANCTUARY PROGRAM**

### **ENROLLMENT AGREEMENT**

This Agreement is made on \_\_\_\_\_, between Homer's Fund, Inc., the administrator of the Apricity Sanctuary Program located at Nine Lives Cat Clinic/Center (hereafter inclusive as "Homer's Fund"), and \_\_\_\_\_, owner/authorized custodian ("donor") of \_\_\_\_\_, ("the cat") listed below.

Homer's Fund has agreed to provide a permanent place of residence for the cat pursuant to this Agreement, subject to the following Terms and Conditions:

1. Homer's Fund has been provided with evidence to confirm, within a reasonable level of doubt, that the cat is (or was, in the case of a deceased donor) the sole property of the donor and is being delivered by the donor or an appropriately authorized person.
2. Homer's Fund has been provided with all requested and necessary documentation including, but not limited to, a completed questionnaire and veterinary medical records, as appropriate. The donor certifies that all information is accurate and complete to the best of his/her knowledge. Submission of fraudulent, altered, or knowingly incomplete information will result in exclusion from the program.
3. Upon delivery of the cat, relinquishment is irrevocable, except at the sole discretion of Homer's Fund. Homer's Fund is from that point forward the owner of the cat, and all responsibility and decisions for future care will be made solely by Homer's Fund.
4. Homer's Fund will provide comprehensive veterinary care for each cat accepted into our sanctuary. Medical decisions will be made solely by Amy D. MacKay, DVM ("Dr. MacKay") and/or her designated authorized representative(s), and will be determined based upon the welfare and well-being of each cat. Should euthanasia become necessary, it will be performed in a loving and humane manner.
5. The cost for acceptance into our program is two thousand dollars (\$2,000.00) per cat. Payment is required prior to delivery of the cat to Nine Lives Cat Clinic/Center. Acceptable payment methods are cashier's check, direct bank deposit, PayPal, or credit card (processing fees may apply). Under no circumstances may a cat enter our sanctuary until payment has been received in full.
6. Any payment made to Homer's Fund pursuant to this Agreement is nonrefundable, regardless of the length of time the cat resides at Nine Lives Cat Clinic/Center.

This Agreement is governed by the laws of the state of Ohio, and any dispute related thereto shall be resolved by the courts of that state.

This Agreement constitutes the entire understanding between the donor and Homer's Fund, and may only be modified by mutual written consent.
